2. Sponsors of the show will provide display tables (up to 4—see above), 2 chairs, electricity, and badges.
3. Exhibiting dealers must supply table covers, risers, shelves, electrical cords, and fixtures necessary for exhibit. Exhibits must be in final display condition by 10:00 AM opening day of the show. No exhibitor will begin closing or packing prior to 3:00 PM closing night. Exhibitors shall wear exhibitor badges at all times while on show premises.
4. Tall Furniture must be placed against the walls or back of booth space.
5. Merchandise must be properly displayed. No Sale or 50% off signs. Please conduct your sales verbally.
6. As required by Colorado law, each vendor must have a valid Colorado Special Events Sales Tax License (for more information contact CO Dept. of Revenue, 1375 Sherman St. Denver, CO 80261).
7. Exhibitors agree that neither the sponsor of the show nor the owner of the building in which the show is held will be responsible or held liable for any loss or damage due to fire, flood, theft, breakage, riots or malicious mischief for the duration of the show. SECURITY WILL BE PROVIDED FRIDAY, SATURDAY AND SUNDAY NIGHTS.
8. If cancellation of this contract is made **in writing** by May 1, 2010, exhibitor's fees will be refunded less \$20.00. If cancellation is made after May 1, 2010, show sponsors will retain all fees.
9. Should the show be cancelled for any reason by Top Hands Organization, Inc. this contract is null and void and the exhibitor waives all claims except refund of booth fees.
