Please include with your completed, signed, and Notarized Application:

- A copy of your birth certificate
- A 4" x 6" color western attire photograph of you
- A letter of recommendation from a non-family member adult who knows you well.
- Include two references from non-family member adult that have worked with you for at least one season in an organized group activity.
- A Written Essay (this will also be your speech topic for the day of competition)
 - Princess and Wrangler essay and speech topic
 - How do cowboys and cowgirls shape today's world?
 - 2 – 3 minutes in length or roughly 3 – 4 pages double spaced 12pt font Times New Roman.
 - JR Princess and JR Wranglers essay topic
 - What qualities make a good cowboy or cowgirl?
 - Written Essay 1 page double spaced 12 pt font
 - Jr. Princess and Jr Wrangler do not have to compete in speech

*Application can be handwritten or typed but **MUST** not be longer than 2 pages (liability waiver and application instructions not included) and **MUST** be completed by applicant.

*The original notarized application with associated documents **MUST** be brought to the day of competition.

*Speeches **MUST** be memorized for all Princesses and Wranglers..
